### Introduction

These Terms of Use (this "Agreement") govern the terms and conditions for using HELP Worldwide, Inc. If you disagree with these terms and conditions or any part of these terms and conditions, you should immediately discontinue all usage of the Site. This Site uses "cookies". By using this Site, you are consenting to our use of cookies in accordance with the terms of our privacy policy. We reserve the right, at any time, to modify, alter, or update the terms and conditions of this Agreement without prior notice.
